

IDEA Dispute Resolution Data Summary for:

Massachusetts 2004-05 to 2015-16

The Individuals with Disabilities Education Act (IDEA) requires states and entities receiving IDEA grants to make available four dispute resolution processes and report annually on each to the U.S. Department of Education Office of Special Education Programs (OSEP). The four dispute resolution processes include written state complaints, mediation, due process complaints, and resolution meetings associated with due process.

The purpose of this summary is to provide an historical look at dispute resolution data and to assist with the identification of trends and changes in the use of the IDEA dispute resolution processes over time. This summary features data for school years ("SY" July 1-June 30) 2004-05 through 2015-16 drawn from CADRE's National Longitudinal Database. Data are collected from the following sources: [1] from SY 2004 to the present, dispute resolution activity reported in states' Annual Performance Reports (APRs), first as Attachment 1 and later as Table 7; [2] from SY 2006 to the present, Section 618 data collected by the Data Accountability Center (DAC) and now (as of SY 2011) reported to EDFacts; [3] data published in OSEP's Annual Report to Congress; and [4] data adjustments collected from states by CADRE after OSEP and DAC data were locked. CADRE examines dispute resolution data for internally inconsistent values (based on report element definitions). When inconsistent values are found, they are reconciled with OSEP. States are encouraged to submit notes or explanations regarding any conditions, anomalies, or corrections relating to the data included herein. In addition, CADRE invites readers to provide input on the usefulness of these reports, including suggestions and adjustments.






Total Dispute Resolution Activity by State/Entity per 10K Childcount:





IDEA Dispute Resolution Activity per 10K Childcount: Massachusetts







IDEA Dispute Resolution Activity: Massachusetts






Relative Use of Dispute Resolution Options: Massachusetts








Written State Complaint Activity per 10K Childcount: Massachusetts






Mediation Activity per 10K Childcount: Massachusetts






Due Process Complaint Activity per 10K Childcount: Massachusetts






Timeliness of Due Process Hearing Decisions per 10K Childcount: Massachusetts
